

**Official Rules**  
**Nevada Prepaid Tuition Scholarship Account Giveaway**  
**Deadline: January 31, 2019**

- **Purchase of a Nevada Prepaid Tuition Program Contract between November 1, 2018 and January 31, 2019 is required to be entered to win.**
- **Sponsor:** The College Savings Board of Nevada is the sponsor of this Nevada Prepaid Tuition Scholarship Account Giveaway.
- **Eligibility Requirements:** This Nevada Prepaid Tuition Scholarship Account Giveaway is open to persons who purchase a Nevada Prepaid Tuition Program through the Nevada Prepaid Tuition enrollment process by Thursday, January 31, 2019 at 11:59 p.m. Enrollment forms will be accepted either online at [www.NVPrepaid.gov](http://www.NVPrepaid.gov) or if delivered in person before close of business, (5:00 p.m.) on January 31, 2019. Mailed entries will be eligible if post marked by January 31, 2019. Parent/guardian consent must be provided before prizes can be awarded to a minor (as determined by Nevada law). Employees of the State Treasurer's Office providing direct support to the Nevada Prepaid Tuition Scholarship Account Contest Giveaway, Board of Trustees of the College Savings Board of Nevada, or advertising/promotional agencies and others who provide support to the Nevada Prepaid Tuition Plan, and their immediate family members and members of their households, are NOT ELIGIBLE to participate. The Nevada Prepaid Tuition Scholarship Account Giveaway begins on November 1, 2018 and closes at 11:59 p.m., on January 31, 2019. Sponsor reserves the right to verify eligibility at any time and reserves the right not to award prizes to ineligible applicants.
- **How to Enter:** All purchasers who purchase a Nevada Prepaid Tuition University Plan (1 year, 2 year, or 4 year plan) or a Nevada Prepaid Tuition Community College Plan (2 year plan) or a Nevada Prepaid Tuition Combination Plan (2 year Community College + 2 Year University) will be entered into the drawing to be awarded a Nevada Prepaid Tuition Plan account. The winner will have their choice of a 1 year University Plan account or a 2 Year Community College Plan account. Neither the Nevada Prepaid Tuition program, nor the State of Nevada Treasurer's office, nor the College Savings Board of Nevada assumes any responsibility for lost, stolen, late or damaged applications.
- **Selection of Winners:** Two (2) winners (total) of a 1 Year University Plan or a 2 Year Community College Plan (collectively referred to hereon as "Winners") will be selected in a random drawing from all eligible Applicants who purchase a Prepaid Tuition Contract with the Sponsor prior to January 31, 2019 at 11:59 p.m. The drawing will be held before the end of the annual open enrollment period, which closes March 31, 2019. Winners will be announced to the public following the verification and notification to the winners. The results of the drawing, and all decisions of the Sponsor as to the administration of the Nevada Prepaid Tuition Scholarship Account Giveaway and the prize awards, are final and binding in all respects. Winners will be notified of their

selection by phone. The State of Nevada Treasurer's Office, and the College Savings Board of Nevada, are not responsible for, and shall not be liable for late, lost, misdirected, or unsuccessful efforts to notify Winners.

- **Prizes:** Two (2) Winners will each receive either a 1 year University Plan account (30 credit hours at the University Level) or a 2 year Community College Plan account (60 credit hours at the Community College Level). Funding for the Nevada Prepaid Tuition accounts will be provided by the College Savings Board of Nevada through the Nevada Higher Education Prepaid Tuition Trust Fund. Nevada Prepaid Tuition Scholarship Accounts may only be redeemed at eligible educational institutions as defined in the 2019 Nevada Prepaid Tuition Program Description and Master Agreement. The Nevada State Treasurer's Office will be named as Purchaser and the minor child will be the Beneficiary. Upon the establishment of the Nevada Prepaid Tuition Scholarship Account, and the designation of the Beneficiary, the Beneficiary can only be changed according to the rules contained within the 2019 Prepaid Tuition Program Description and Master Agreement. Upon matriculation, when the Beneficiary is ready to use the Nevada Prepaid Tuition Scholarship Account, he or she must contact the Nevada Prepaid Tuition administrators to request a distribution to their school, following all Nevada Prepaid Tuition Program rules, as defined in the 2019 Nevada Prepaid Tuition Program Description and Master Agreement. At the time the beneficiary matriculates from high school and completes the required notification forms, i.e., the "Intent to Enroll" form, it will be reviewed and approved by the Nevada Prepaid Tuition Trust Fund staff prior to the distribution of payment to the eligible educational institution for the benefit of the Beneficiary. This Nevada Prepaid Tuition Scholarship Account will expire 6 years from the Beneficiary's expected matriculation date unless the Beneficiary qualifies for an extension of use as defined in the Program Description and Master Agreement. Any remaining balance or unused credits will be returned to the Nevada Higher Education Prepaid Tuition Trust Fund. No additional contributions can be made to the Nevada Prepaid Tuition Trust Fund account.

Winners are urged to consult a tax advisor regarding tax consequences of any prize in light of the Winner's individual circumstances. Prizes not claimed within thirty (30) days after the date on which the notification was made will be forfeited and awarded to the next alternative winner, in accordance with these Official Rules. All prizes are awarded "AS IS" WITHOUT WARRANTY OF ANY KIND, EXPRESS OR IMPLIED, INCLUDING WITHOUT LIMITATION WARRANTIES OF FITNESS FOR A PARTICULAR PURPOSE.

- **Odds of Winning:** Odds of winning depend on the number of Nevada Prepaid Tuition Program Contracts purchased between November 1, 2018 and January 31, 2019.
- **Privacy Policy: Subject to "Use of Winner's Information" below, any** information provided to Nevada State Treasurer's Office through participation in the Nevada Prepaid Tuition Scholarship Account Giveaway is used only in accordance with the State of Nevada Treasurer's Office Privacy Policy, as amended from time to time, currently located in the 2019 Nevada Prepaid Tuition Program Description and Master Agreement, which can be accessed at [www.nvprepaid.gov](http://www.nvprepaid.gov).

- **General Terms and Conditions:** This Nevada Prepaid Tuition Scholarship Account Giveaway is void wherever prohibited or restricted by law. By participating in this Nevada Prepaid Tuition Scholarship Account Giveaway, all participants and their parents/guardians agree to be bound by all the Official Rules of this Nevada Prepaid Tuition Scholarship Account Giveaway and the decisions of the Sponsor, which shall be final. All federal, state and local laws and regulations apply. Neither the Sponsor, nor the State of Nevada Treasurer's Department Staff, nor the College Savings Board of Nevada, nor any other State of Nevada employee, is in any way responsible or liable for damage, loss or injury resulting from human error, altered, illegible, late, lost, or misdirected applications, events beyond their control, or acceptance and use of a prize. Winner assumes liability for any injuries caused or claimed to be caused by participating in the Nevada Prepaid Tuition Scholarship Account Giveaway or by any prize. Sponsor reserves the right to suspend or terminate the Nevada Prepaid Tuition Scholarship Account Giveaway or any entrant's participation in the Nevada Prepaid Tuition Scholarship Account Giveaway should unauthorized human intervention or other causes beyond Sponsor's control affect the administration, security or proper payout of the Nevada Prepaid Tuition Scholarship Account Giveaway, or Sponsor otherwise becomes (as determined in its sole discretion) incapable of running the Nevada Prepaid Tuition Scholarship Account Giveaway as planned. Participants who violate these Official Rules, tamper with the operation of the Nevada Prepaid Tuition Scholarship Account Giveaway or engage in any conduct that is detrimental or unfair to Sponsor, the Nevada Prepaid Tuition Scholarship Account Giveaway or any other individual (in each case as determined in Sponsor's sole discretion) are subject to disqualification from entry into the Nevada Prepaid Tuition Scholarship Account Giveaway. Sponsor reserves the right to lockout any person whose eligibility is in question or who has been disqualified or is otherwise ineligible to enter the Nevada Prepaid Tuition Scholarship Account Giveaway. Capitalized terms used herein and not defined in this document shall have the meanings defined in the 2019 Nevada Prepaid Tuition Program Description and Master Agreement.
- **Certificate and Consent.** As a condition of being awarded any prize, Winners will be required to execute and deliver to Sponsor a signed Certificate of Eligibility and Acceptance of these Official Rules and release of liability. By entering, participant and his or her parent/guardian agrees that no claim relating to losses or injuries shall be asserted against the Nevada State Treasurer's Office, the College Savings Board of Nevada, the State of Nevada, the Nevada Higher Education Prepaid Tuition Trust Fund, or any of their affiliates, directors, officers, shareholders, employees or agents. By accepting a prize, Winner agrees to and shall be deemed to release and hold harmless the Nevada Higher Education Prepaid Tuition Trust Fund, the College Savings Board of Nevada, the State of Nevada Treasurer's Office or staff, and any other employee of the State of Nevada against any and all losses, damages, rights, claims and actions of any kind resulting from or arising in connection with the Nevada Prepaid Tuition Scholarship Account Giveaway or acceptance, delivery, misdelivery, possession or use of or inability to use any prize, including without limitation, personal injuries, death and property damage, rights of publicity or privacy, defamation or portrayal in a false light, whether intentional or unintentional, and whether under a theory of contract, tort theory

(including negligence), warranty or other theory. Winners shall be required to provide the Sponsor with all necessary beneficiary information (i.e., beneficiary name, address, date of birth and social security number) to open the Nevada Prepaid Tuition account.

- **Use of Winner's Information.** Sponsor may use a Winner's name, age, city of residence, photo, video and any testimonial in marketing, outreach and promotion of the program and/or contest. Sponsor may ask the winner's Parent/Grandparent/Guardian and the winner (Student Beneficiary) to appear on local TV or Radio and the winner will be expected to reasonably accommodate the public appearance request. Every effort will be made by the Sponsor to make sure the date and time of any public appearance celebrating the win works for all parties involved.
